OVERVIEW

Aging Services of Washington and Plante Moran have teamed to offer a series of affordable, up-to-date distance learning educational sessions about the process of completing the Minimum Data Set (MDS) 3.0 **that has undergone several revisions since its inception October 1, 2010 and with more expected April 1, 2012.** The MDS drives everything in long-term care (survey, quality indicators/quality measures, data for Nursing Home Compare, reimbursement) and with the new process, accuracy of the MDS will be a challenge for the interdisciplinary team. We will break down the MDS 3.0 section by section, plus, we are offering two sessions designed for the senior leadership of your organization.

Successful surveys demand accurate MDSs. To provide the best information to consumers the facility must generate accurate MDSs. Rightful reimbursement for Medicare and Medicaid requires an accurate MDS. Each of these 12, 90-minute sessions is designed to build on one another and fit the current needs of all disciplines involved in the assessment process. Each session will have time for questions and answers. The team can hear and see the same information at the same time via audio format; no travel expenses for the community and continuing education credits included.
